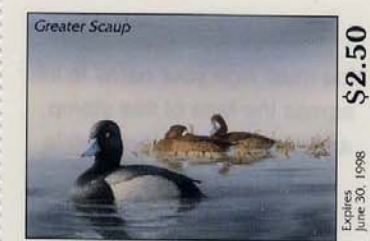

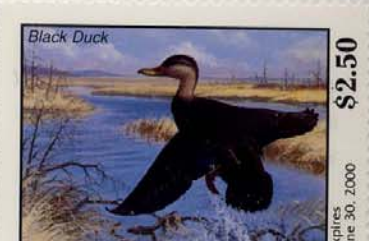

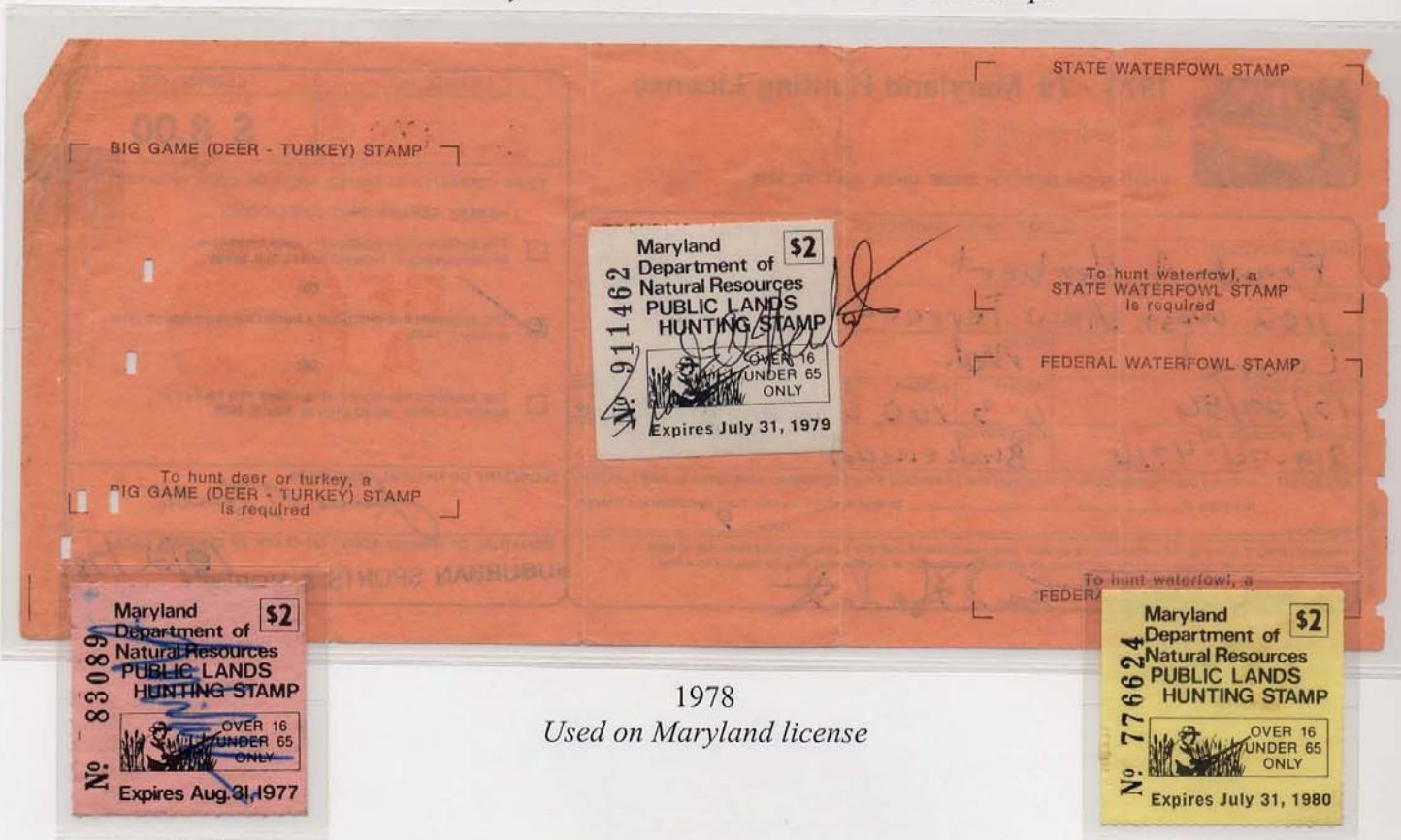
# MARYLAND PUBLIC LANDS HUNTING STAMPS

# MARYLAND DUCK BLIND STAMPS

*Duck blind stamps are required for hunters who hunt in offshore stationary blinds that they own or lease. Stamps are printed in strips of three with matching serial numbers. When issued, one stamp was affixed to the hunter's permit. The other two were for record-keeping purposes..*

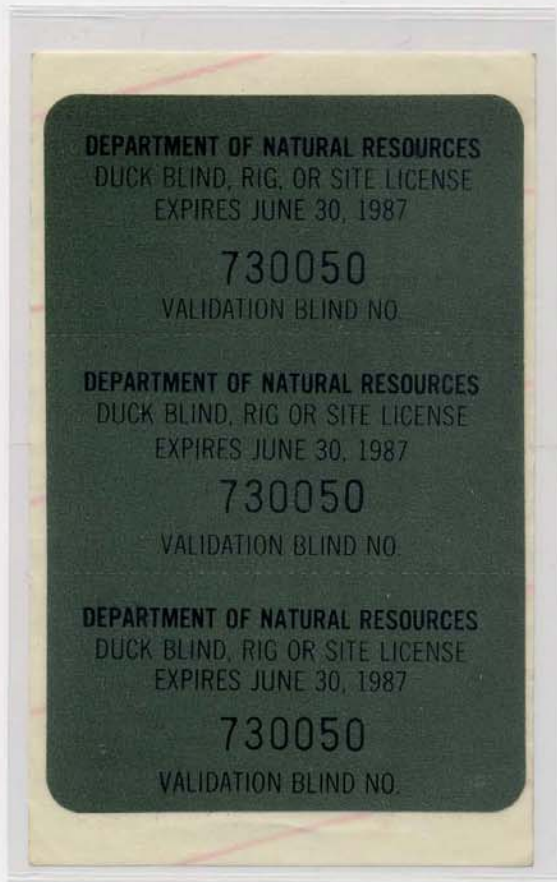

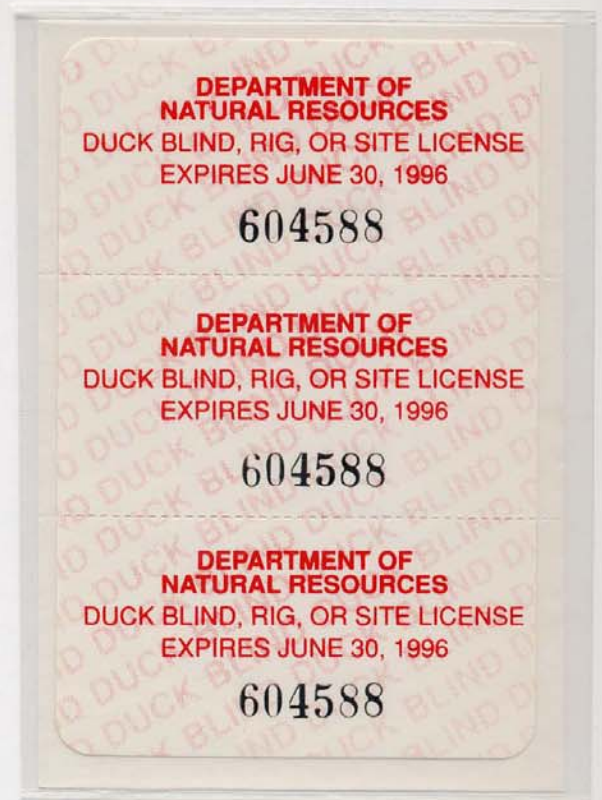

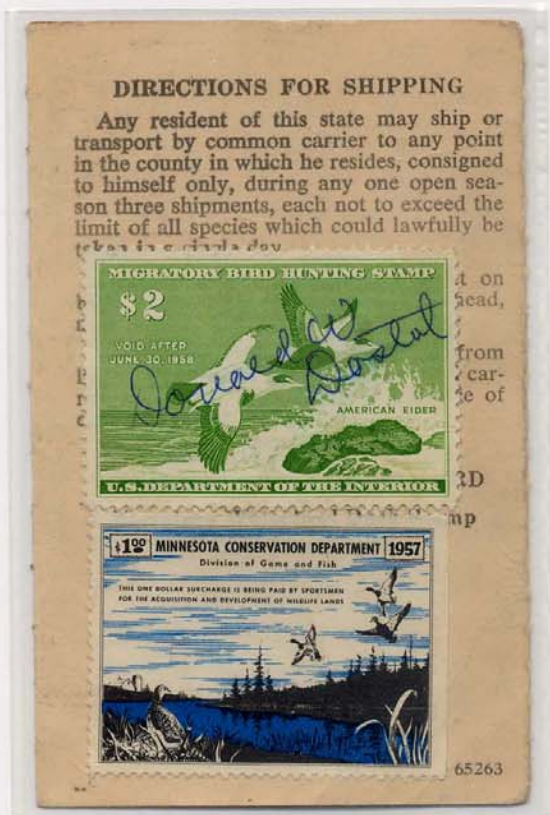

# MINNESOTA

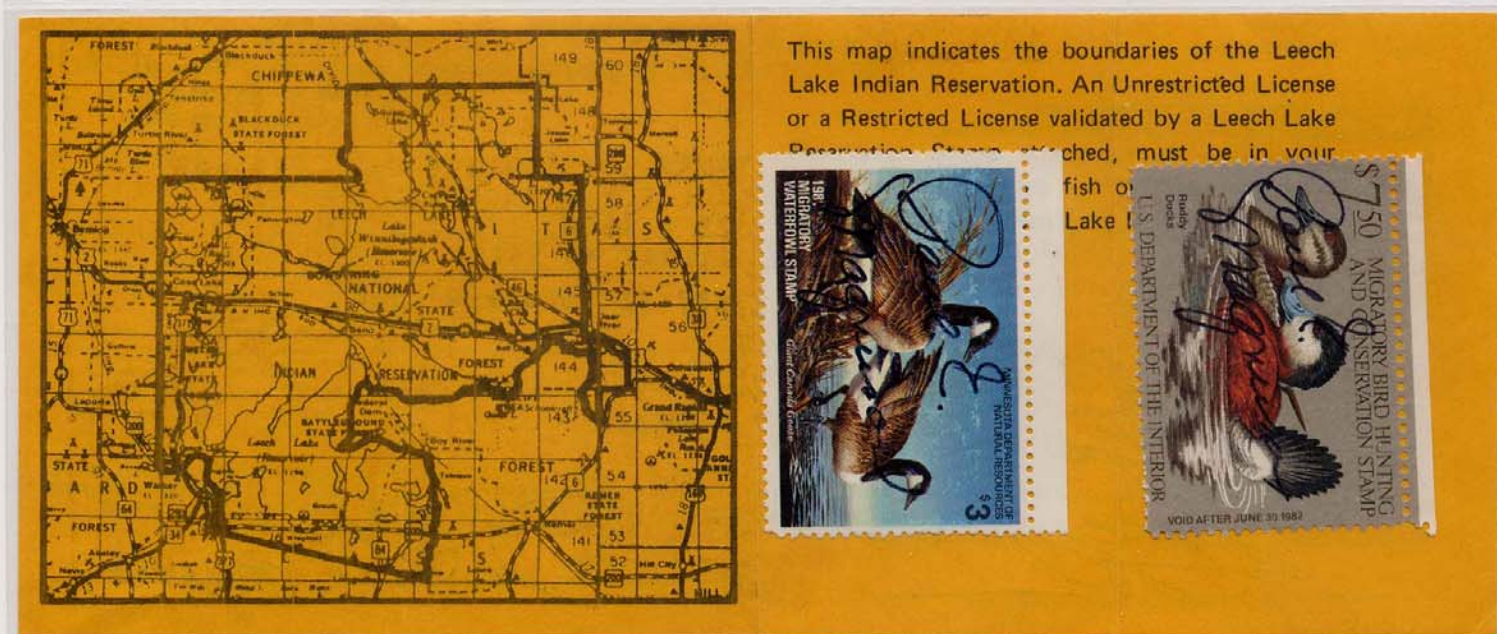

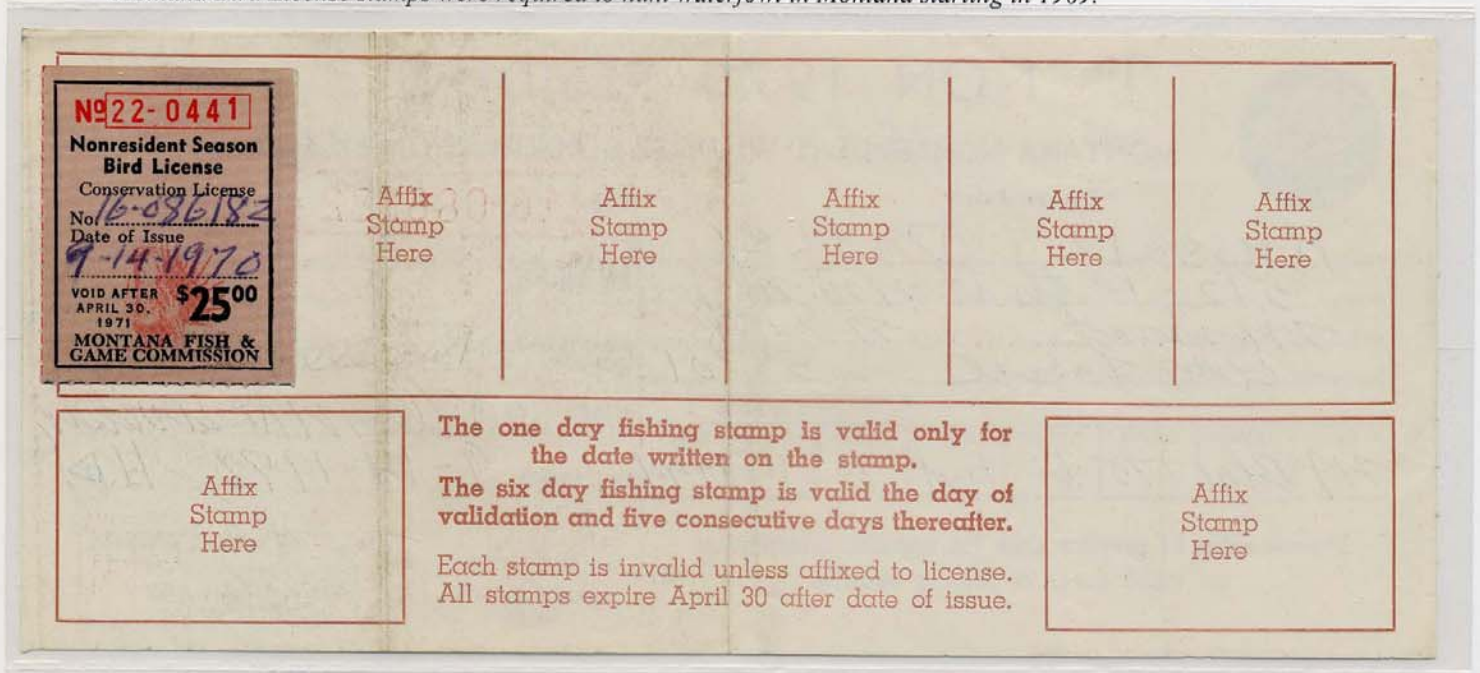

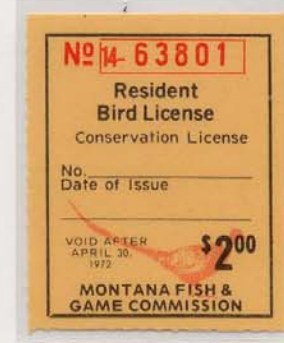
