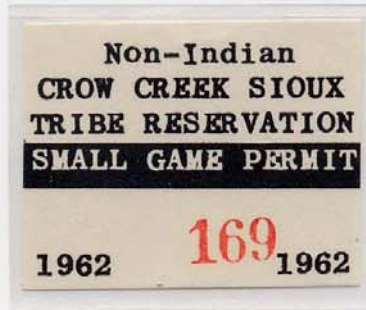


INDIAN RESERVATION STAMPS CROW CREEK SIOUX RESERVATION

The first stamps required for waterfowl from Crow Creek were issued in 1962. No stamps were issued from 1965 through 1988. In 1989, Crow Creek became the first Indian Reservation to issue pictorial license stamps.

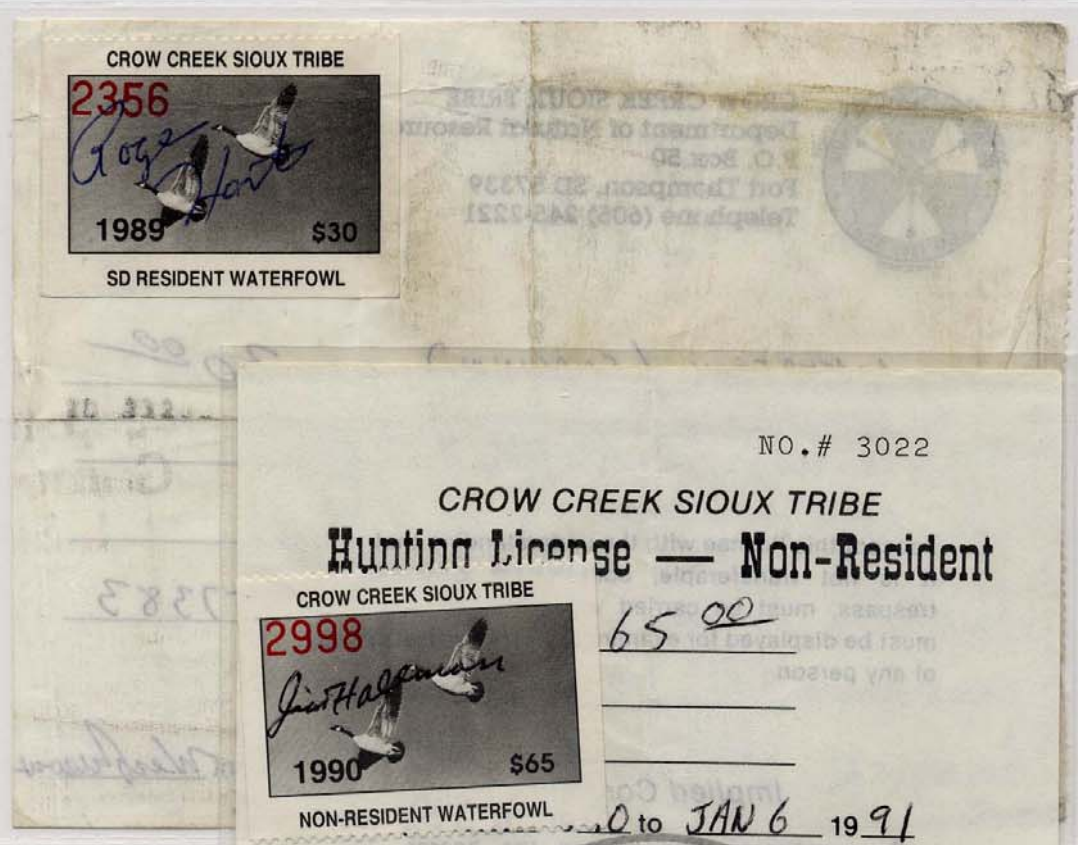

The tribal council raised the resident fee to \$65.00, the same as non-residents. Instead of making a new stamp, non-resident stamps were used for residents.

The non-resident Sportsman stamps have the highest face value (\$250) of any stamp required to hunt waterfowl



*1989 Resident Sportsman stamp used on Crow Creek Reservation license. With the purchase of a sportsman stamp, a hunter could hunt for small or upland game, deer, varmint and waterfowl. They could also fish. The tribal member sportsman stamp **only** conveyed the right to hunt furbearers. (includes raccoon, fox, badger, weasel, coyote, skunk, mink and beaver).*

200 of each Crow Creek sportsman stamp were printed and issued to vendors in 1989, with the exception of the tribal member stamp which had a printing of 300.

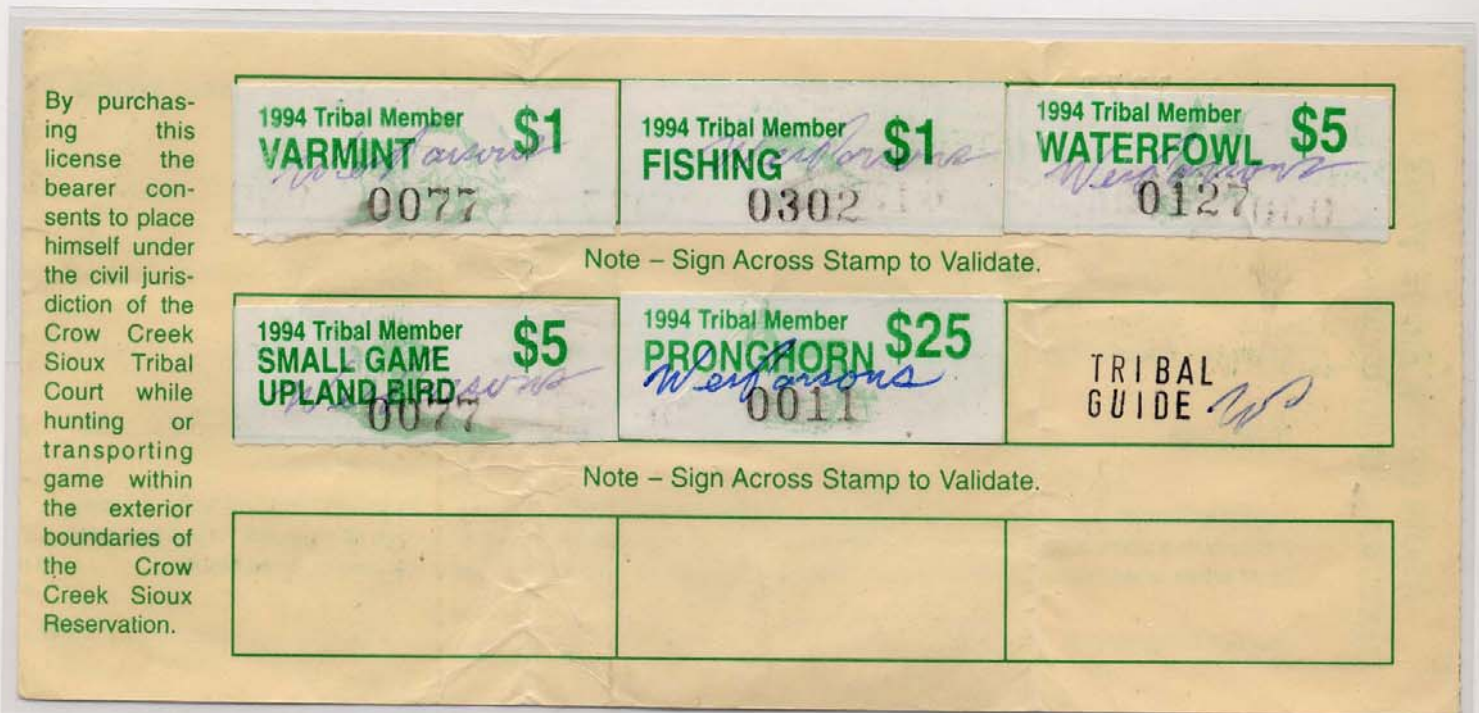

The waterfowl stamps were printed with a face value of \$25.00, when the fee was actually \$30.00. The error was not discovered until after the stamps were distributed. A few were sold before they were recalled and replaced with the correct stamps.



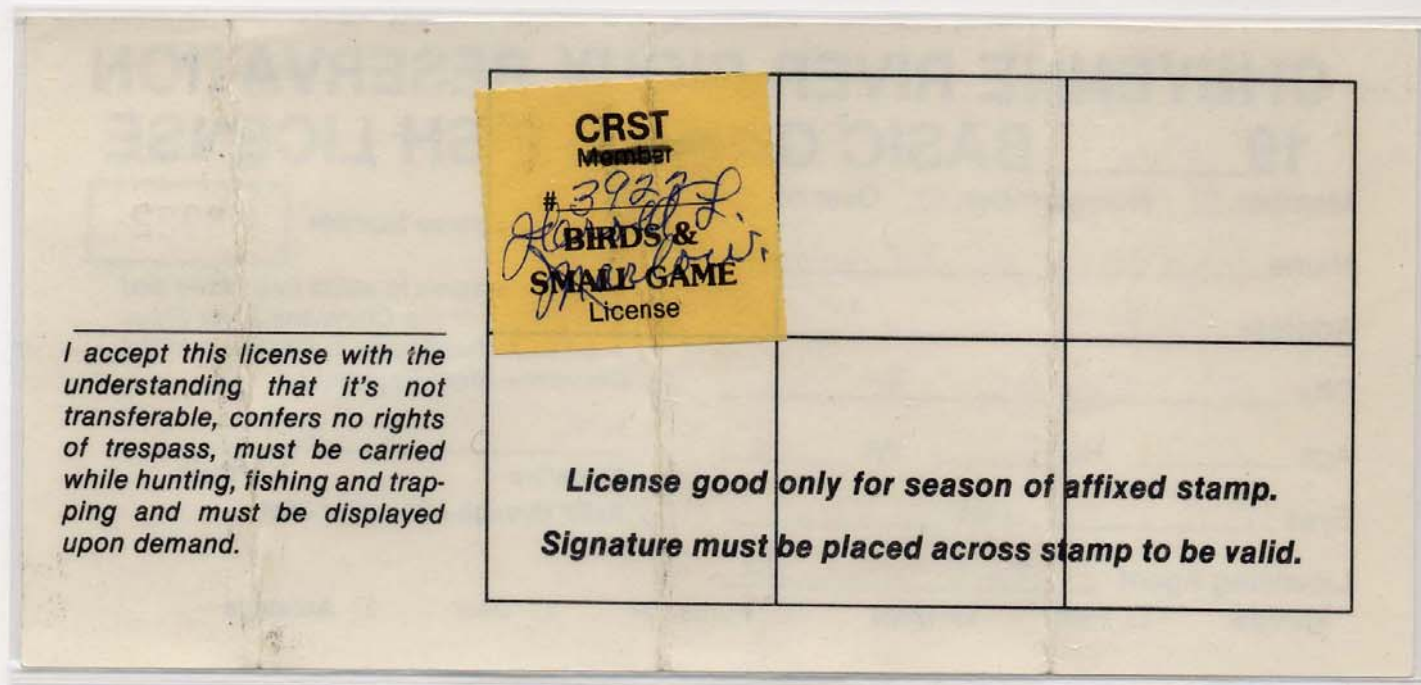

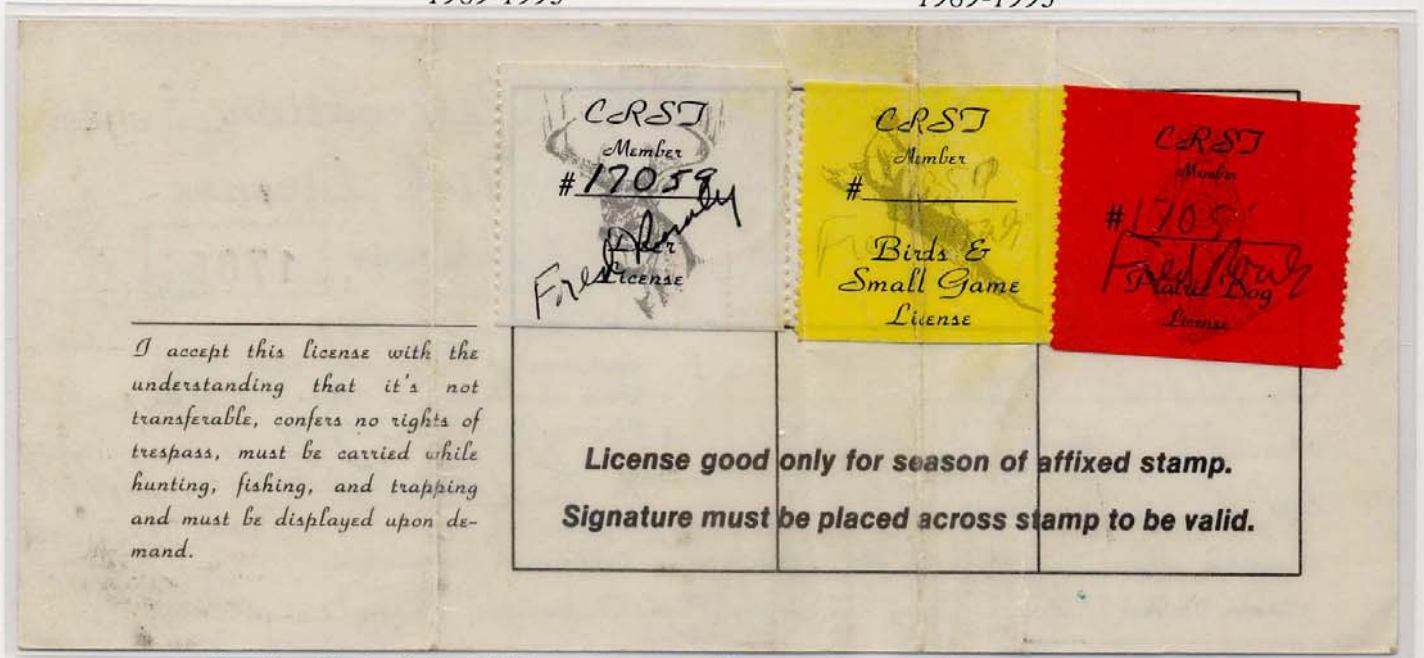

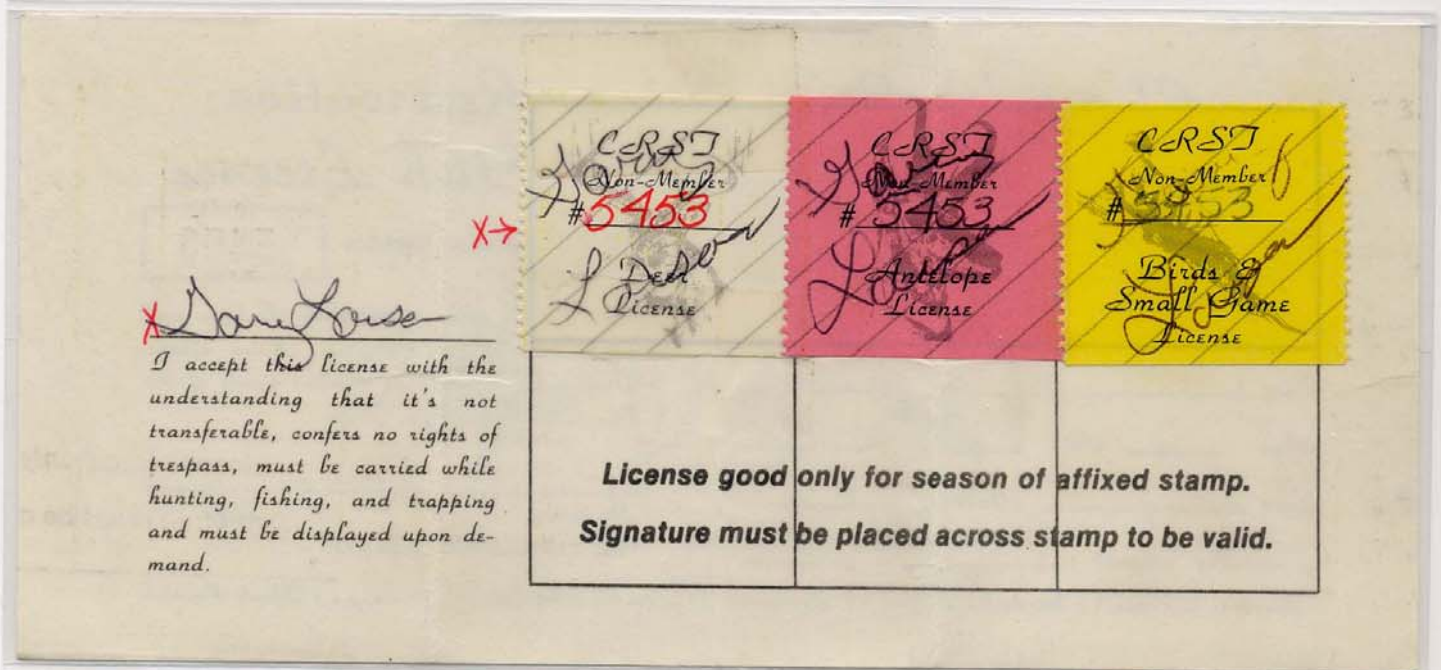

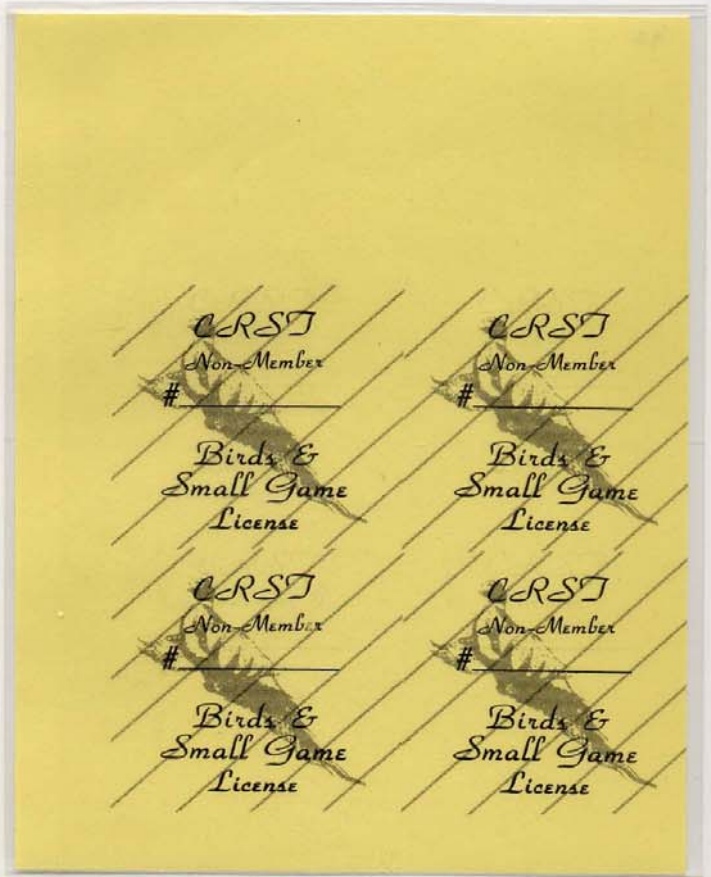
